Discussion included that there would be a full report of revenue generated from Weed Control, Aggressive Source Reduction, Abated Properties, and Rebates included in the December 2018 Agenda. The annual percent change for West Region CPI-U monthly for October 2018 was 3.5% according to the Bureau of Labor Statistics. According to Board policy, this is above the 3% cap but the employees have indicated no intent to negotiate, so the next expected COLA will be 3%.
