B. Consideration and adoption of the "Notice to File an Abatement Lien" and Resolution 2018-07 against property owned by Laurence and Francene Garcia located at 5201 S Waring Rd., Denair, CA 95316. (APN 045-043-048). Mr. Garcia would like to be reinstated on the Aggressive Source Reduction MOU. He told the District Board that he can pay \$200.00 tonight and will bring in a check for \$150.00 tomorrow (9/18/18).
