GM Heft reviewed the valuation report with the board noting that the District's CERBT fund was now super funded due to improved investment returns and less employees as predicted opting in to CALPERS health benefits after retirement. To address this, the District will be transferring money out of the CERBT trust over the next several years to pay its CALPERS annual contribution for OPEB..
