A. Consideration and adoption of the "Notice to Abate Nuisance" and Resolution 2017-05 as filed against Jose Padilla ET AL to determine if a public nuisance exists at 9007 E Keyes Rd, Denair, CA (APN 045-044-038)

GM Heft provided evidence to support the filing a Notice to Abate Public Nuisance in regards to the property located at 9007 E Keyes Rd, Denair, CA. GM Heft also noted to the board that Mr. Padilla did not sign the District's Aggressive Source Reduction (ASR) Memorandum of Understanding (MOU) which would have protected him from civil penalties. The Board concurred with staff's findings. Any instance

of mosquito breeding will result in reimbursement of the District's costs and \$100.00 per day civil penalty. After 10-days of non-compliance, the civil penalty will increase to \$200.00 per day.

GM Heft provided evidence to support the filing a Notice to Abate Public Nuisance in regards to the property at 5601 Mountain View Rd, Turlock, CA. GM Heft also noted to the board that Mr. Teixeira said he would repair the leaking headgates on property but the work has not been done. The Board concurred with staff's findings. Any instance of mosquito breeding will result in reimbursement of the District's costs and \$100.00 per day civil penalty.
